## **Frequently Asked Questions**

## **Comprehensive Plan, City of Worthington**

February 25, 2025 DRAFT

- 1. What is a comprehensive plan? A Comprehensive Plan is a long-term guide that expresses the values and aspirations of a community. It is the broadest public policy document a community can create for its future physical development considering the input of citizens, businesses, and other stakeholders. It includes a vision about the future condition of the City; goals and desired outcomes for topics like land use, housing, economics, parks, and transportation; and specific actions to achieve the goals. The plan is a tool to prepare for change and acts as both a business plan and guidebook for decision-makers. Worthington's comprehensive plan is used regularly to guide many city decisions such as budgeting, zoning and other regulations, and infrastructure investment.
- 2. **Why do we need a new plan?** Worthington last completed a full update of the Comprehensive Plan in 2005. Since that time, portions of the Plan have been revised and more narrowly focused plans have been adopted (e.g. Northeast Area Plan, Wilson Bridge Corridor Study, Bicycle & Pedestrian Master Plan, Parks Master Plan), Given the changed and continually evolving national, regional and local dynamics, it is time to pursue consideration of the entire Comprehensive Plan.
- 3. How does the comprehensive plan relate to Vision Worthington? Vision Worthington was a community visioning effort led by a Visioning Committee comprised of Worthington residents appointed by City Council. It was a citizen-led process with broad community engagement that culminated in the adoption of eight vision statements covering seven vision areas in March 2021. The visions highlight the community's values and describe the community's desired future. Vision Worthington focused on overarching interests to pursue over the long term. The Comprehensive Plan should align with Vision Worthington and will focus on the physical development of the community. - 4. **Will the UMCH site be addressed in the plan?** The Comprehensive Plan will consider all areas of the community including sites along the major corridors such as 1033 High Street, 6700 North High Street and the north side of Wilson Bridge Road.
- 5. What is the Community Committee and how were members selected? The Community Committee is a diverse group of 18 community members appointed by the City to provide guidance and direction regarding the plan process and substance and to serve as advocates for the plan. The committee members were either nominated or selected through an open application process that yielded many talented, passionate, and qualified individuals. The committee members are collectively representative of many interests, geographic areas, professions, and demographics, of the city's population.
- 6. What is the timeline for completing the plan? The plan update is a significant undertaking that is anticipated to last approximately 14-16 months. It is expected to be completed in early 2026.
- 7. **Will there be opportunities for others to get involved?** Yes, there will be three distinct rounds of community input through in-person events and online activities. The first opportunity is being planned for early 2025.

# Community Committee Overview

## **Comprehensive Plan, City of Worthington**

February 25, 2025

This document provides an overview of the Community Committee for the City of Worthington's comprehensive planning process.

## **Background**

The City of Worthington is undertaking an effort to define a long-term vision for the City's growth and development in the coming decades. The new plan will build upon the recent Vision Worthington, reflect changes that have occurred within and around the City over the past 20 years, and set the direction for the City's development in the coming years. It is crucial that this plan be built on the values, needs and aspirations of the community. To ensure this happens, a diverse group of community members, known as the Community Committee will be convened to support the process.

In addition to the Community Committee, other groups who will be involved in the process include:

## **Community Committee**

Process leadership

The Committee is a diverse group of community members that will meet regularly throughout the process provide guidance on the process and substance of the Plan, will serve as community advocates, and may serve as stewards of the completed Plan.

### **City Staff**

Coordination

City staff will support and help coordinate the work of all other groups and provide local knowledge and expertise.

## **Subject matter experts**

**Targeted input** 

Various interested parties and subject matter experts will convene to inform specific aspects of the plan. These groups include business leaders, neighborhood associations, real estate professionals and developers, education professionals, students, young professionals, and others to be identified.

### **Elected Officials**

Monitor and adopt

City Council and the MPC will monitor the process through input and periodic briefings with the expectation to formally adopt the final plan. City Council will have a central role in implementation through regulatory updates or funding allocations. Planning Commission will support implementation through the development review process.

### Public

Input and feedback

Community participation is vital to the plan's success. Three distinct rounds of engagement opportunities and online tools will offer a variety of different ways for the community to give input throughout the process.

### Consultants

Process leadership, expertise

Planning NEXT will facilitate the process and share experience from other successful communities. Burgess & Niple, Ninigret Partners, and Realm Collaborative will facilitate the process and provide technical expertise.

## **Committee Role and Job Description**

The Community Committee will help guide the plan. Members will work closely with the City's planning staff, the consultant team and other community members to bring insight and perspective to the planning process. They will help spread the word about the planning effort to encourage community participation. They will also advise on the plan's substance, helping staff and the consultant team to integrate the community's intuition with technical analysis. The Committee will meet formally approximately seven or eight times during the 14-16 month effort.

## Responsibilities

- Participate in-person for seven to eight committee meetings during 2025 (some meetings may support a hybrid or virtual format, but in-person participation is preferred)
- Represent the public in the planning process.
- Provide guidance and direction to the staff and consultants at crucial steps in the process.
- Act as spokespersons for the effort.
- Serve as hosts at public events during the process.
- Volunteer to facilitate at public meetings (training will be provided).
- Recruit volunteers to assist with conducting outreach and facilitation at public meetings.
- Disseminate information during the planning process through individual networks.
- Recommend substance for the draft plan (role is advisory)
- Assist in presenting the plan for adoption before appropriate adopting bodies.

## **Operating Principles**

To guide the committee's deliberations, the following operating principles are proposed:

- Trust the process
- Keep an open mind
- Prepare for complex conversations
- Contribute to a safe setting
- Work toward alignment
- Enjoy the experience
